*Tracking:* Tracking will be on a Fescue/Bermuda Hayfield. Articles will be leather, wood, and carpet. There will be no tracking on trial fields prior to the trial.

*Trial Location:* Behind 3435 Watson Rd, Cumming GA 30028. Use Gravel Drive at dark fence. Directions: 400N. Merge onto GA-20 W/Buford Hwy via EXIT 14 toward Cumming. Continue on GA-20 for approximately 7 miles. Turn right onto Friendship Cir. Turn slight left onto Hurt Bridge Rd. Turn left onto Watson Rd. Parking Entrance on Left in 0.2 miles.
